In support of strengthening student academic achievement, <u>C.J. ## **ANNUAL TITLE I MEETING**

<u>C.J. Hicks Elementary</u> will take the following actions to conduct an Annual Title I Meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the School Parent and Family Engagement Plan, the Schoolwide Plan, and the School-Parent Compact.

An Annual Title I meeting will be held at the beginning of each school year in the evening prior to October 31st. All parents will be invited and encouraged to attend. Schoolwide Title I information will be distributed to explain the delivery of services available to students, the system and school's goals, parents' responsibilities, parents' rights to be involved, and the plans to meet the requirements of the Title I program. The Title I program will assist parents in understanding the State, County and school's curriculum, and Title I goals and objectives. It will be available to all parents. Parents and the school will be encouraged to set high expectations for their children and become familiar with and understand the curriculum. ### **COMMUNICATIONS**

<u>C.J. Hicks Elementary</u> will take the following actions to provide parents of participating children the following:

C.J. Hicks Elementary School is a schoolwide Title I school and all parents are invited and encouraged to attend all Title I meetings, trainings and workshops. Flyers will be available to announce upcoming meetings/workshops. We also post meeting dates and times via our website, marquee, Remind, and School Messenger phone system.

Monthly school and Title I newsletters, a schoolwide phone system, informal communication, personal telephone calls, and at least two (2) parent-teacher conferences will keep parents informed of upcoming Title I programs and activities. A parent information board will be available for parents that will include school and PTA news.

Meetings/workshops for parents will be offered at flexible times so parents are able to participate in the school's programs. Meetings/workshops will be both virtually and in-person. Parents will be surveyed as to the type of programs they consider to be most beneficial, the schedule, and the location of meetings and/or workshops. The planned meetings/workshops will afford parents the opportunity to share experiences with other parents, formulate suggestions, and participate in decisions relating to the education of their children.

#### **COORDINATION OF SERVICES**

<u>C.J. Hicks Elementary</u> will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by:

Area businesses and community members will be invited to participate in school events and provide information on resources made available to parents. Sponsors will be used in supporting PTA events. Community members' services will also be included in conducting parent training workshops/sessions. The district also offers PTAs for parents of students attending district schools. C.J. Hicks will ensure that parents are aware of these services offered by the district. Our Kindergarten Transition Team will work closely with area daycares to provide resources and services for parents. All stakeholders are encouraged to become involved in the school.

Parents are encouraged to contact our Parent Liaison should they need support and/or resources. A copy of the school's Parent and Family Engagement Plan is available in the Parent Resource Center and on the school's Title I page. Within the Parent Resource Center, materials are available on topics relative to student academic success, assessments, State standards, homework help, report card information, and other pertinent topics.

#### **BUILDING CAPACITY OF PARENTS**

<u>C.J. Hicks Elementary</u> will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards;
- Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement; and
- Providing assistance to parents, as appropriate, in understanding topics such as the following:

A minimum of four (4) parent workshops will be provided for parents during the school year. Topics for these workshops will be based on student and parent needs. Part of the training will include strategies that parents can use at home to reinforce literacy and numeracy skills. Parents will be provided with and trained to use several resources, including technology and tools to utilize in the home setting. Instructional Coaches and district-level coaches, along with teachers, will provide support and academic help skills to parents. Instructional materials and literature about how to help children succeed in school will be distributed.

Parents are invited to attend Title I workshops and meetings that are specific to the dissemination of Title I information.

Parents are provided written documentation about the State curriculum in the fall, and as requested throughout the school year. Parents will be provided with assistance in interpreting the County's standards-based grading system and report cards. Parent-Teacher conferences will be an arena where parents will be given additional assistance to understand student performance levels.

#### **BUILDING CAPACITY OF SCHOOL STAFF**

<u>C.J. Hicks Elementary</u> will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

C.J. Hicks will provide training to educate the teachers, pupil services personnel, principal, and other staff on how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and how to implement and coordinate parent programs and build ties between parents and the school. Several times each year, the district Superintendent will host open forums for parents and community members to share their concerns, advice, suggestions, ask questions and learn about the direction of the Rockdale County Public Schools.
